

Basic terms & conditions of Civil Liability and Medical Insurance.

Civil Liability:	\$200,000 Dlls maximum for the event.
Emergency Medical limit:	\$ 5,000 Dlls maximum per participant. \$100,000 Dlls maximum per the event.
Funeral Expense	25% of the insured sum of the Emergency Medical coverage of the participant.
Legal Assistance	Bail Bond Service

The Insurance only covers the vehicles that are “paid in full” entries for the event.

Coverage stops on the insured race vehicle when the race vehicle either finishes the stage or the event, is disqualified, is “declared out of the event” for any reason, or when the event vehicle time has been stopped, or when the time limit on the event or the stage has expired.

There are no refunds after the start of the policy.

Coverage is enforce for any and all of the insured vehicles only when being used in their official capacity during the event.

The driver and co-driver must be officially registered in the event. Additionally they must wearing a “wrist band” on the days of the race that was issued by the officials of the event with the race number that corresponds with the same race vehicle that they are participating in.

Any accident, damages or injuries to a third party must be reported to the insurance carrier or their authorized representative during the days of coverage.

This coverage provides for a professional legal bonding service that would be required in the event of any judicial proceedings filed in the Mexican Republic against the driver operating their registered race vehicle, as the result of a covered bodily injury accident in Mexico during the time frame of the coverage.

The driver of the insured vehicle is required to cooperate and keep the bond in effect by attending any and all legal or court proceedings in Mexico, in connection with the accident that took place during the time frame of coverage.

Coverage excludes:

- Any damages or injuries that occur in a pit area or while pitting.
- Any damages or injuries incurred when the event/race vehicle is outside of the official event/race course on the days of coverage for the event.
- Any damages or injuries when an event/race vehicle is in violation of any traffic laws at the time of an accident.
- Any pre-existing medical conditions of the participant, driver or passengers.
- Damages to the insured event/race vehicle, or any other event vehicles.
- Any participant/race driver found to be under the influence of drugs or alcohol.
- Any and all medical services provided outside the country of Mexico.
- Any participant/race driver “under” the age of 16 during the time frame of coverage.
- Any bonding service as of a result of property damage.
- Any travel or transit going to the event, and traveling away from the event.
- Any air ambulance transport or service.
- Any transport or service by any Red Cross facility or equipment in the Republic of Mexico.
- Any pollution, contamination or ecological damages.
- Any damages or injuries to members, volunteers or vehicles of the same team.
- Any and all legal proceeding, court judgment/settlement or case filed outside the Republic of Mexico
